Using the iPad

- I understand that the iPad will be used for educational purposes only.
I will only use School Apps at school downloaded from comp portal
I will bring my iPad to school every day with 100% battery.
I will close all Apps and Safari tabs before coming to school.

Taking care of the iPad

- I will make sure my iPad is in my bag when I go to and from school.
I will keep the iPad away from food and drink at all times.
I will have a protective case that has a transparent front screen cover with a sturdy backing.
I will hold the iPad with two hands when carrying it and will walk with it at all times.
I will keep my iPad in the classroom at all break times unless directed otherwise by my teacher.
I will have an image of myself holding the IPAD agreement on the lock screen so my iPad can be identified.
I will take responsibility for any damage or malfunction to the iPad and have the iPad repaired as quickly as possible.

Software and Apps

- I understand that my parents will enrol my iPad into Intune and install my Year Level Apps and Core Apps.
I will have the current iOS and regularly update all Apps.
I will not install 12+ Apps or content on the iPad (Facebook, Messenger, Snapchat, Instagram, TikTok, Discord, Capcut, Twitch or any other apps/sites that require users to be over 13 years).
I will manage my Home Apps in by storing them on a hidden page (they will be shown how to do this) and leaving adequate space for school Apps, projects and photos, minimum 16GB.

Safety and Security (BYOD and Shared Devices)

- I will be responsible for my passwords and not share them with others.
I will only take photos, videos and voice recordings on my iPad when instructed by my teacher.
I will only use search topic related to my learning at school.
I will only set up my EQ email on my iPad, Messenger & Facetime will be disabled,
I will not upload photos from school to any internet site, or distribute them in any way.
I will be cyber safe when using the internet.
In Classroom App, I will select ALWAYS ALLOW for my teacher to access "Lock Apps and Devices/ AirPlay and View Screen".
I understand that the iPad will be used for educational purposes only.
We recommend removing the Apple ID to stop them downloading apps or messaging
